Admission and Financial Contract

The admission agreement is made between White Horse Christian Academy and the student's parent(s) or legal guardian(s) listed above. In consideration of the services provided by White Horse Christian Academy, the parent or guardian agrees as a policy of enrollment their student must abide by the terms and conditions as follows:

1. The parent or guardian will pay the school all applicable fees as described in the Tuition and Fees Schedule and the Financial Agreement in the manner and at the time required therein.
2. The parent or guardian agrees they must comply with all health, safety, and discipline policies of White Horse Christian Academy. The parent will cooperate fully with White Horse Christian Academy to ensure full compliance with all rules and guidelines.
3. The parent or guardian will complete and return all questionnaires and forms given to the student by White Horse Christian Academy. Prompt return of complete and accurate documentation by the parent is a condition of enrollment.
4. The parent or guardian agrees enrollment may be terminated without cause and that the parent or guardian is responsible for any fees and costs incurred before termination of enrollment.
5. Parents agree to keep the school informed of any medical and/or behavioral concerns of their child throughout their enrollment and that the parent or guardian has received a “Parental Consent and Medical Authorization.”
6. The parent or guardian agrees to pay for any property damage or medical services resulting from the child’s care and acknowledges that White Horse Christian Academy cannot be responsible for the child’s lost or damaged property.
7. The parent or guardian agrees to comply with all reasonable requests of White Horse Christian Academy necessary to accomplish the school’s purpose.

8. The parent or guardian agrees that any complaint he/she may have concerning White Horse Christian Academy will first be directed to the school's administration and not directed to other parents or children. If the parent remains unsatisfied, a complaint will be presented to the school's board of directors.
9. The parent or guardian agrees that as a condition of enrollment, he/she will submit to binding arbitration instead of civil litigation in case of an unresolved dispute. The binding arbitration terms are described in the White Horse Christian Academy Arbitration Policy.
10. The parent or guardian understands and agrees that violation of the school's tenets of faith, discipline policy, safety procedures, school policies, and regulations or this admission agreement by the parent/guardian or student is grounds for the student's discipline or termination of this agreement and the student's enrollment.
11. **Separate Billing**
Each family will be issued one statement for their account. Should a parent/guardian living in separate households request that their bill be divided between the households, please notify the office of the request in writing. However, both parties understand that they are equally responsible for the full amount of the account. Should one party refuse to pay, the other party will be held accountable for the unpaid balance.
12. **Returned Check Policy**
Any check returned to White Horse Christian Academy or non-funded recurring payment will be assessed a \$30 fee.
13. **Enrollment Termination/Early Withdrawal**
Records will not be released for any student with a balance. If you withdraw your student for any reason, you are still responsible for the full tuition before the records are released.
14. **Student Financial Suspension**
The basic policy is that any student's tuition overdue beyond the 10th of the month following the billed month is cause for suspension until the account is current.
15. **Before School Care and After School Care**
At this time, White Horse Christian Academy does not offer before-school care or after-school care. The parent/guardian is expected to drop off and pick up the student within 15 minutes of school starting and ending.
16. **Tuition is a yearly charge. If you enroll in White Horse Christian Academy, you are responsible for the full tuition.**
